In signing this form, I understand this is an annual term membership. I agree to allow eESI to deduct my membership dues and any family member's dues from my paycheck.

Employee agrees that the payroll deduction set up with eESI Payroll Department will not be stopped prior to the established term of the membership unless due to the termination or resignation or unusual circumstances not limited to medical or military. eESI must notify Gold's Gym in writing that the deduction should be stopped prior to the end of the term.
